Momentum Children's Charity event place terms and conditions

By applying for a Momentum Children's Charity challenge event place at an event organised by a third party, you accept and agree to abide by the following terms and conditions:

- 1. You commit to raising the minimum sponsorship for Momentum Children's Charity for the event for which you have registered. Each charity place at an event represents an important and valuable source of fundraising for us. As we have made an investment to be able to offer places, we ask each applicant to pledge to raise a minimum level of sponsorship if they subsequently take part. We can, of course, provide help and advice with your fundraising activities if required.
- 2. You understand that your registration fee is not refundable.
- 3. You will also be required to sign up to, and comply with, the event organiser's event rules and/or terms and conditions. Please read these carefully, as they will set out the event organiser's obligations and liabilities to you and vice versa. Momentum Children's Charity is not responsible for the organisation or management of the event, and therefore we shall have no liability to you for any injury, damage or loss suffered by you when taking part in or in connection with the event.
- 4. You confirm that, to the best of your knowledge, your general state of health and fitness is good, and you take full responsibility for your training.
- 5. All monies that you raise in connection with the event are held on trust for Momentum Children's Charity, and therefore you have a legal responsibility to ensure that all sponsorship monies/donations received in connection with an event are paid to us. We ask that you do this as soon as possible, **but in any event within 4 weeks after the event**.
- 6. For events with a minimum sponsorship over £300, at least 50 per cent of your minimum sponsorship should be paid to Momentum Children's Charity at least 3 weeks before the event.
- 7. We reserve the right to cancel your place prior to the event (with notice) should you not achieve the fundraising targets as set out.
- 8. If you do not take part in the event, any sponsorship money raised will be treated as donations unless your sponsors contact Momentum Children's Charity directly for a refund.
- 9. You agree to raise all money using legal methods.
- 10. You understand that Gift Aid is not included in your minimum sponsorship. The money raised from Gift Aid is a valuable bonus for Momentum Children's Charity.
- 11. If you are granted a Momentum Children's Charity place, please note this place is nontransferable. Any attempt to transfer your place may result in this place being lost, and you will not be entitled to a refund if you have paid a fee for your place.
- 12. You confirm that you will be the minimum age required to take part in the event. For Information on age requirements for specific events, please email sportsevents@ momentumcharity.org
- 13. You agree to Momentum Children's Charity storing the information that you provided on their database. Please see our privacy policy for details.
- 14. Event participants will be offered a free running vest or t-shirt to wear when fulfilling the fundraising target conditions. This is a great opportunity to raise awareness of Momentum Children's Charity and to show who you have been raising funds for; we would very much appreciate you ensuring that you wear it at the event.
- 15. You give Momentum Children's Charity permission to use any photographs or videos taken of you at this event, to raise awareness or money for Momentum Children's Charity's work.
- 16. You agree that Momentum Children's Charity may share your details with the event organiser.
- 17. By signing up, you agree that the Momentum Children's Charity Events team can contact you by email and phone about your participation in the event for which you have registered. This is only for the purpose of communicating essential event information.
- 18. When taking part in an event, we ask that you avoid behaving in any way which may cause offence or damage the reputation of Momentum Children's Charity, for example by using aggressive or abusive language, or by behaving in a way which may cause injury or harm to other participants and/or spectators.
